Dear Nominee,

A proposed Settlement of the above-noted securities class action has been reached. Enclosed are copies of the Notice of (I) Pendency of Class Action and Proposed Settlement; (II) Settlement Hearing; and (III) Motion for Attorneys' Fees and Litigation Expenses and Proof of Claim and Release Form ("Notice Packet") that the Court has ordered be timely sent to potential Settlement Class Members.

The Court has directed that, if you are a broker or other nominee that purchased iRhythm Technologies, Inc. ("iRhythm") common stock from July 25, 2022 through August 9, 2024, inclusive (the "Class Period"), for the beneficial interest of persons or organizations other than yourself, **WITHIN SEVEN (7) CALENDAR DAYS OF YOUR RECEIPT OF THE ENCLOSED NOTICE PACKET, YOU MUST EITHER:**

- (i) Request from the Claims Administrator sufficient copies of the Notice Packet and the link to the electronic Notice Packet to forward to all such beneficial owners and within seven (7) calendar days of receipt of those Notice Packets and links to the electronic Notice Packet forward the Notice Packets to all such beneficial owners for whom you have postal mailing addresses and forward the link to the electronic Notice Packet to all such beneficial owners for whom you have email addresses (if you have both forms of address for the same beneficial owner, send the Notice Packet by both means); or
- (ii) Provide a list of the names, mailing addresses, and, if available, email addresses, of all such beneficial owners to the Claims Administrator.

If you choose the second option above, the Claims Administrator will send the Notice Packet to the beneficial owners.

Brokers, nominees, and their agents shall forward the Notice Packet to (or identify names, mailing addresses, and email addresses of) all beneficial owners who purchased iRhythm Technologies, Inc. common stock during the Class Period, regardless of whether or not those beneficial owners have enrolled in a claim-filing program with their broker or financial institution.

If you do not have any beneficial owners that are potential Settlement Class Members in this litigation, please confirm via email to info@iRhythmSecuritiesLitigation.com.

Upon full compliance with these directions, such nominees may seek payment of their reasonable expenses actually incurred, by providing the Claims Administrator with proper documentation supporting the expenses for which reimbursement is sought. Reasonable expenses shall not exceed:

- **\$0.05 per name, address, and email address**, if you are providing the records to the Claims Administrator, OR
- **\$0.05 per Notice Packet mailed, plus postage at the current pre-sort rate used by the Claims Administrator**, if you are requesting the Notice Packet and performing the mailing, AND **\$0.05 per email of the electronic link to the Notice Packet**.

All invoices must be received within 30 days of this letter.
